JURISDICTION AND FUNCTIONS OF THE COMMITTEE

The Congressional Budget Act of 1974 established the Committee on the Budget. The Budget Committee is responsible for developing and reporting the annual concurrent resolution on the budget (budget resolution), assembling and reporting any reconciliation legislation required by that resolution, and implementing and governing the congressional budget process generally. The Committee Chairman is responsible for assessing the budgetary effects of legislation under consideration in the House, monitoring such legislation for compliance with the terms of the budget resolution, and providing updated information to the House with respect to budgetary aggregates and allocations.

In addition to its legislative duties, the Budget Committee has responsibility for oversight and studies related to various aspects of the budget process. The Budget Committee oversees the Congressional Budget Office (CBO) and conducts oversight of budget execution practices. As the Committee with oversight over the Federal budget in the broadest sense, it examines significant economic and public policy issues and their implications for the Federal budget. The Committee carries out these oversight and examina-

tion responsibilities through hearings, requests for budgetary information from executive branch agencies, requests to CBO and the Government Accountability Office to research and analyze specific topics, and Committee-generated analytic reports.

SUMMARY OF ACTIVITIES

MAJOR LEGISLATIVE INITIATIVES

H.R. 2021, INVESTING FOR THE PEOPLE ACT OF 2019

On April 2, 2019, Chairman Yarmuth introduced H.R. 2021, the Investing for the People Act of 2019, a 2-year budget to provide for and adjust discretionary funding levels for fiscal years 2020 and 2021. On April 3, 2019, the Budget Committee considered the bill and ordered it to be reported favorably to the House by a roll call vote of 19 Yeas to 17 Nays. The bill raises caps imposed on discretionary spending by the Budget Control Act of 2011. In addition, it includes two new adjustments to non-defense discretionary caps to adequately fund the 2020 Census and reinvigorate Internal Revenue Service enforcement capabilities.

BUDGET ENFORCEMENT RESOLUTION FOR FISCAL YEAR 2020

On April 8, 2019, Chairman Yarmuth introduced H. Res. 293, a resolution providing for budget enforcement for Fiscal Year 2020 consistent with the Investing for the People Act of 2019 as reported by the Budget Committee. It was adopted through H. Res. 294 (House Report 116-37) on April 9, 2019 by a roll call vote of 219 Yeas to 201 Nays (Roll No. 161).

H. Res. 293 establishes spending and revenue aggregates and committee allocations, including an allocation for discretionary spending for the Appropriations Committee. The resolution caps Overseas Contingency Operations funds and includes two new adjustments to the discretionary allocations to adequately fund the 2020 Census and reinvigorate Internal Revenue Service enforcement capabilities.

H.R. 3877, BIPARTISAN BUDGET ACT OF 2019

On July 23, 2019, Chairman Yarmuth introduced H.R. 3877, the Bipartisan Budget Act of 2019 (BBA of 2019), which became Public Law No. 116-37 on August 2, 2019. The BBA of 2019 amended the Balanced Budget and Emergency Deficit Control Act of 1985 to increase the discretionary spending limits for fiscal years 2020 and 2021.

The legislation also includes procedures to establish and enforce congressional budgets for 2020 and 2021, including committee allocations, aggregate spending and revenue levels, and limits on advance appropriations. In addition, it suspends the public debt limit for 2 years to avoid default.

LEGISLATION REASSERTING CONGRESS' POWER OF THE PURSE PURSUANT TO ARTICLE I OF THE CONSTITUTION

H.R. 6628, CONGRESSIONAL POWER OF THE PURSE ACT

On April 28, 2020, Chairman Yarmuth introduced H.R. 6628, the Congressional Power of the Purse Act. The legislation reclaims

Congress' Constitutional spending authority by restoring Congress' central role in funding decisions, increasing transparency in the executive branch, and safeguarding the nation's separation of powers.

H.R. 8363, PROTECTING OUR DEMOCRACY ACT

Chairman Yarmuth was an original sponsor of H.R. 8363, the Protecting Our Democracy Act, introduced on September 23, 2020. The bill is a landmark reform package that will prevent future Presidential abuse and specifically strengthens Congress' power of the purse by enhancing the Impoundment Control Act of 1974.

OTHER LEGISLATIVE ACTIVITIES

H. Res. 6, Adopting Rules for the 116th Congress

The organizing resolution (H. Res. 6) adopted by the House on January 9, 2019, contained several provisions related to the congressional budget process. H. Res. 6 provides that the Rules of the 115th Congress are the Rules of the 116th Congress with amendments.

H. Res. 6 removes the macroeconomic scoring analysis requirement for the Congressional Budget Office and Joint Committee on Taxation when preparing estimates on the budgetary effects of major legislation.

H. Res. 6 also removes the point of order prohibiting amendments to general appropriation bills that propose a net increase in the level of budget authority in a bill to allow amendments that increase spending without offsetting that increase, so long as the amendment does not cause the bill to exceed 302(a) or 302(b) budget allocations.

Further, H. Res. 6 reinstates a Pay-As-You-Go (PAYGO) rule. The provision establishes a point of order against any measure that has a net effect of increasing the deficit or reducing the surplus over two periods: (1) the current fiscal year, the budget year, and the four fiscal years following that budget year; and (2) the current fiscal year, the budget year, and the nine fiscal years following that budget year. The provision provides that net budgetary effects will be determined relative to baseline estimates provided by the Congressional Budget Office consistent with section 257 of the Balanced Budget and Emergency Deficit Control Act of 1985, but provides that if a measure is considered pursuant to a special order that instructs the Clerk of the House to add the measure to another measure passed by the House, then the net budgetary effects of the entire package will be considered. Finally, the provision provides for exemptions to PAYGO for provisions designated as emergencies in legislation.

In addition, H. Res. 6 provides that when the House adopts a budget resolution, a separate joint resolution suspending the Federal debt limit through September 30th of the budget year is deemed to have passed the House by the same vote and is engrossed separately and sent to the Senate.

H. Res. 6 also includes separate orders relating to budget process. It provides that any general appropriation bill or joint resolution continuing appropriations, or amendment thereto or conference report thereon, may not provide an advance appropriation for a program, project, activity, or account, unless it has been identified

in a statement submitted for printing in the Congressional Record by the Chair of the Committee on the Budget. Further, it provides that in the first session of the 116th Congress and prior to the adoption of a Fiscal Year 2019 budget resolution, the provisions of H. Con. Res. 71, from the 115th Congress, pursuant to section 30104(f)(1) of the Bipartisan Budget Act of 2018, will no longer be in effect except for sections 5201, 5202, 5203, and 5401.

H. Res. 7, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on January 3, 2019, and elected Mr. John A. Yarmuth as Chair of the Committee on the Budget.

H. Res. 8, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on January 3, 2019, and elected Mr. Womack to the Committee on the Budget.

H. Res. 73, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on January 24, 2019, and elected Mr. Moulton, Mr. Jeffries, Mr. Khanna, Ms. DeLauro, Mr. Doggett, Mr. Price of North Carolina, Ms. Schakowsky, Mr. Higgins of New York, Mr. Kildee, Mr. Boyle of Pennsylvania, Mr. Panetta, Mr. Morelle, Mr. Horsford, Mr. Scott of Virginia, Ms. Jackson Lee, Ms. Lee of California, Ms. Jayapal, and Ms. Omar to the Committee on the Budget.

H. Res. 74, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on January 24, 2019, and elected Mr. Woodall, Mr. Johnson of Ohio, Mr. Smith of Missouri, Mr. Flores, Mr. Holding, Mr. Stewart, Mr. Norman, Mr. Roy, Mr. Meuser, Mr. Timmons, Mr. Crenshaw, Mr. Kevin Hern of Oklahoma, and Mr. Burchett to the Committee on the Budget.

H. Res. 85, Electing Members to Certain Standing Committees of the House of Representatives and Ranking Members on A Certain Standing Committee of the House of Representatives

This resolution was agreed to on January 29, 2019, and elected Mr. Higgins to rank immediately after Mr. Jeffries and Mr. Boyle to rank immediately after Mr. Higgins to the Committee on the Budget.

H. Res. 125, Electing Members to A Certain Standing Committee of the House of Representatives and Ranking A Member on Certain Standing Committees of the House of Representatives

This resolution was agreed to on February 13, 2019, and elected Mr. Sires, Mr. Peters, and Mr. Cooper to the Committee on the Budget.

H. Res. 481, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on July 10, 2019, and elected Mr. Hern to rank immediately after Mr. Norman on the Committee on the Budget.

H. Res. 870, Electing A Member to A Certain Standing Committee of the House of Representatives and Ranking A Member on Certain Standing Committees of the House of Representatives

This resolution was agreed to on February 27, 2020, and elected Mr. Khanna to rank immediately after Mr. Cooper on the Committee on the Budget.

H. Res. 1058, Electing Members to Certain Standing Committees of the House of Representatives

This resolution was agreed to on July 21, 2020, and elected Mr. Jacobs to the Committee on the Budget.

BUDGET TRACKING AND ENFORCEMENT

The Committee on the Budget worked with authorizing committees and the Appropriations Committee to monitor legislation and evaluate its compliance with H. Res. 293, the BBA of 2019, the Statutory Pay-As-You-Go Act of 2010, and any budget related provisions of the Rules of the House. Pursuant to provisions of the Congressional Budget Act, the Chairman periodically published budgetary status reports in the Congressional Record (see Appendix 1). Pursuant to the Statutory Pay-As-You-Go Act, the Chairman published estimates of the PAYGO budgetary effects of legislation being considered in the House (see Appendix 2).

OVERSIGHT ACTIVITIES

The primary responsibility of the Budget Committee is the development of a budget resolution that sets spending and revenue levels in aggregate and across all budget functions. The budget functions encompass all Federal programs or activities other than those that are defined as off-budget, such as Social Security and the Postal Service, and those that are considered non-budgetary, such as the Federal Reserve.

The Budget Committee's formal oversight responsibility focuses on laws governing the budget process and the agencies responsible for administering elements of those laws. The Committee's communication with CBO and the executive branch is outlined in Appendix 3, and bills referred to the Committee are outlined in Appendix 4. Under clause 1(d)(1)–(3) of House Rule X, the major laws falling within its oversight include the Budget and Accounting Act of 1921, the Congressional Budget and Impoundment Control Act of 1974, the Balanced Budget and Emergency Deficit Control Act of 1985, the Budget Enforcement Act of 1990, the Statutory Pay-As-You-Go Act of 2010, the Budget Control Act of 2011, and the BBA of 2019. The two agencies with primary responsibility for administering elements of these laws and hence which fall under the Committee's jurisdiction are the Office of Management and Budget (OMB) and CBO.

The Committee was active in its oversight duties during the 116th Congress. The Committee focused on oversight of the full budget, particularly looking at issues of potential impact on the budget and economy over the longer term, including immigration, climate change, health care, and tax policy (see list of hearings).

The House Budget Committee met on January 29, 2019, to organize for the 116th Congress. The Committee adopted its rules of procedure and in accordance with clause 2(d) of House Rule X, submitted the oversight plan, along with minority views, to the Committee on Oversight and Reform and the Committee on House Administration. The priorities of the oversight plan include holding hearings and receiving testimony from Members of Congress, Cabinet-level and other Federal officials, and expert witnesses to review the President's budget submissions and to review other budget priorities.

The Committee's oversight plan calls for focusing on how a range of issues, including immigration, climate change, health care, and tax policy, impact the Federal budget. The oversight plan also calls for the continuous assessment of the performance of Federal agencies in both administration and service delivery by reviewing performance data in the President's budget submissions and the relevant reports and audits of the Government Accountability Office and the Offices of the Inspectors General. In addition, it calls for the Budget Committee to review Views and Estimates that are submitted to the Committee pursuant to section 301(d) of the Congressional Budget Act, to coordinate its oversight activities with other committees.

With regard to budget enforcement, the Committee's oversight plan calls for ongoing oversight of the OMB implementation of budget submission, control, execution, and enforcement of procedures under the Budget and Accounting Act of 1921, the Congressional Budget and Impoundment Control Act of 1974, the Budget Enforcement Act of 1990, the Balanced Budget and Emergency Deficit Control Act of 1985, the Statutory Pay-As-You-Go Act of 2010, the Bipartisan Budget Act of 2018, and other applicable laws. In addition, the Committee's oversight plan calls for examining the accuracy, timeliness, and responsiveness of OMB.

The Budget Committee's plan also calls for working with the appropriations and authorizing committees to ensure that spending and tax legislation does not breach the levels set in the budget resolution, as required under sections 302(f) and 311(a) of the Congressional Budget Act of 1974. The Committee also monitored compliance with the House Pay-As-You-Go (PAYGO) rule requiring that direct spending increases and revenue losses be offset with either direct spending reductions or revenue increases.

APPOINTMENT OF THE DIRECTOR OF THE CONGRESSIONAL BUDGET OFFICE

On May 15, 2019, Dr. Phillip Swagel was jointly appointed by the Speaker of the House of Representatives and President pro tempore of the Senate as the Director of CBO, effective June 3, 2019 for the term expiring January 3, 2023. The appointment can be found on page H3835 of the Congressional Record. This appointment was made on Chairman Enzi's recommendation and supported by Chairman Yarmuth.

MINORITY VIEWS

SUMMARY REPORT

Since taking the House Majority in the 116th Congress, House Democrats have failed to govern and failed to do their job—to write and pass a budget resolution, the primary responsibility of the Budget Committee. Instead of fulfilling its chief responsibility for two consecutive years, Committee Democrats focused Committee business on partisan policy hearings (that more appropriately should have been conducted by the relevant authorizing committees of jurisdiction) and completely neglected to address the Nation’s fiscal challenges.

Before the COVID–19 pandemic attacked the Nation, the Federal Government was on a fiscally unsustainable path; the deficit for Fiscal Year 2019 was an overwhelming \$1 trillion. Today the Congressional Budget Office (CBO) is projecting the deficit for Fiscal Year 2020 to be \$3.1 trillion, more than triple last year’s deficit and by far the highest in American history. Public debt is projected to be larger than the size of the entire economy in Fiscal Year 2021—104 percent of gross domestic product (GDP)—and will continue to increase to more than \$33 trillion by Fiscal Year 2030 (109 percent of GDP). Given the dire fiscal trajectory we face, it is disconcerting that, as of the writing of the Minority views, there is still no budget resolution in place for the current fiscal year.

LEGISLATION

H.R. 2021, INVESTING FOR THE PEOPLE ACT OF 2019

In April 2019, the Democratic Majority decided to curtail the budget process by introducing and marking up H.R. 2021—legislation to increase the discretionary spending limits for Fiscal Year 2020 and Fiscal Year 2021—rather than writing a budget resolution. H.R. 2021 failed to address 10-year discretionary spending, mandatory spending, and revenues, in addition to other key budget resolution requirements that establish a fiscal framework for subsequent spending and revenue legislation. Budget Committee Republicans offered a motion to postpone the markup of H.R. 2021 to provide the Democratic Majority additional time to write a budget resolution. The Democratic Majority rejected this motion. Republicans offered several amendments including ones to align the Fiscal Year 2020 discretionary spending limits with the President’s Fiscal Year 2020 budget request; require offsets in mandatory spending for the increases made to the discretionary spending limits; and extend the discretionary spending limits beyond Fiscal

Year 2021. All amendments offered by the Republican Minority were rejected.

Unlike past legislation to increase the discretionary spending limits, H.R. 2021 lacked bipartisan input and participation by the Administration. The House ultimately never considered H.R. 2021.

H.R. 3877, BIPARTISAN BUDGET ACT OF 2019

In July 2019, the House of Representatives considered H.R. 3877, the Bipartisan Budget Act of 2019, which increased the discretionary spending limits for Fiscal Year 2020 and Fiscal Year 2021. Congressional leaders and the Administration negotiated H.R. 3877, which passed the House on July 25, 2019, with a bipartisan vote of 284 yeas and 149 nays. House Budget Committee Chairman John Yarmuth (D-KY) and Ranking Member Steve Womack (R-AR) each managed bill debate on the House floor. President Trump signed H.R. 3877 into law on August 2, 2019.

BUDGET PROCESS REFORM LEGISLATION

The congressional budget process is broken. Fiscal Year 1995 was the last time Congress adhered to the budget timetable and deadlines—as defined in statute—by adopting a conferenced budget resolution followed by individual appropriations bills to fund the Federal Government before the start of the fiscal year. Since then, the Federal Government has been routinely operating via ad hoc budget procedures including continuing resolutions and omnibus appropriations bills. Clearly, the budget process established in the Congressional Budget Act of 1974 needs to be reformed to ensure we have a process that not only works, but also one which can successfully correct the current fiscal trajectory.

Instead of focusing on budget process reform legislation to fix the broken congressional budget process through bipartisan solutions, Committee Democrats took a partisan approach by introducing H.R. 6628, the Congressional Power of the Purse Act. H.R. 6628 was limited in scope and focused solely on authority over congressional spending and the separation of powers. It ultimately failed to address the more pressing budget challenges including continuously missed deadlines in adopting a budget resolution and funding the government. Most of the reforms proposed in H.R. 6628 were in response to actions taken by the Trump Administration. H.R. 6628 established an expiration date for any Presidential declaration of a national emergency, created burdensome requirements for making various executive branch agency documents and information publicly available, among other reforms targeted at the executive branch.

Budget Committee Republicans repeatedly expressed interest in budget process reform and a majority of Republican Members introduced pieces of bipartisan reform legislation. In the 116th Congress, Budget Committee Republicans introduced several bills focused on reforming the broken budget process. These include:

- H.R. 3982, STEWARD Act, sponsored by Representative Bill Flores (TX-17), established procedures for Congress to set limits on discretionary spending.

- H.R. 4071, sponsored by Representative William Timmons (SC-4),¹ required the budget resolution to include a recommended ratio of the public debt to estimated GDP for each fiscal year covered by the budget resolution.
- H.R. 5178, sponsored by Representative Tim Burchett (TN-2), established a debt-to-GDP ratio in the budget resolution and expedited procedures to recommend changes in law to meet these debt-to-GDP ratios.
- H.R. 4959, Pro-Growth Budgeting Act, sponsored by Representative Kevin Hern (OK-1), required estimates of major legislation prepared by the Congressional Budget Office or Joint Committee on Taxation to include macroeconomic effects.
- H.R. 4115, sponsored by Representative Bill Johnson (OH-6), established a point of order prohibiting the consideration of legislation that increased long-term direct spending by more than \$5 billion in any of the four decades after the budget window.
- H.R. 3979, BASIC Act, sponsored by Representative Dan Meuser (PA-9), required estimates of legislation prepared by the Congressional Budget Office or Joint Committee on Taxation to include the costs of servicing the public debt.
- H.R. 4559, End-of-Year Fiscal Responsibility Act, sponsored by Representative Dan Crenshaw (TX-2), prohibited executive branch agencies from spending more in each of the last 2 months of a fiscal year than the agency's average monthly spending for the previous 10 months.
- H.R. 5490, sponsored by Representative Chris Stewart (UT-2), required the President's annual budget submission to include an estimate of the cost per taxpayer of the deficit and the public debt.
- H.R. 5220, AFTER Appropriations Act, sponsored by Representative Ralph Norman (SC-5), provided for a legislative line-item veto to expedite the consideration of rescissions and cancellation of new direct spending and limited tax benefits.
